On 6 July 2021, the *National Energy Authority Act 2021 (NEA Act)* came into force with the publication in the National Gazette of notices of commencement of the Act. The National Energy Authority (the Authority) is now established and has the power and responsibility to obtain, licence and regulate the Generation, Transmission, Distribution and Retailing of Electricity and all other energy related activities in the country.

EXECUTIVE MANAGER – ECONOMIC REGULATION

This position is accountable to the Managing Director and is responsible for the effective and efficient operations of the Economic Regulation Division and in particular in regulating and licensing of the Electricity Industry.

Key Responsibilities:

- Assist the Managing Director in planning and managing and coordination of the Economic Regulation Division to achieve its mandated goals and responsibilities
- Assist the Managing Director to oversee and monitor the operations of the Division
- Ensure that the electricity industry service quality standards are conformed to by service providers both on-grid and off-grid mini grids
- Ensure to update the service quality standards of the electricity industry when and where applicable to reflect on changes in the industry
- Ensure that tariffs and feed-in-tariffs are set in accordance with the NEA Act 2021 and in accordance with the appropriate regulations
- Ensure that the issuing of electricity licences and permits to electricity undertakers and Independent Power Producers (IPPs) must be done in accordance with the NEA Act and the appropriate regulations.

Expected Competencies:

- Master's Degree in Engineering, Economics, MBA or other relevant qualification
- Minimum of 8 years work experience with a minimum of 5 years at a management level either in the public or private sector
- Possess good organizational and administrative ability, together with good analytical and research capability
- Possess good interpersonal character, with good negotiation and communication skills both written and verbal
