Key Responsibilities:

- Developing and implementing the ANL Commercial Strategy
- The commercial performance of all passenger sales based aspects of company operations, including working with the GM-Cargo and the GM-Network and Revenue (who manages the "back of office" support and systems that assist the sales teams in succeeding)
- Managing all domestic sales offices, the offshore relationships with all GSA's and Travel Agent, code-share and SPA relationships with peer airlines
- Managing the marketing for Air Niugini, including with industry partners such as tourism and the resource industry (including securing resource closed charter contracts)
- Providing strategic leadership and coordination in the administrative, business planning, and budgeting for the Commercial section
- The refinement and periodic review of the commercial strategy, including delivering on metrics tied to that strategy
- Staff management and continuous development of teams, processes and systems.
